VOLUNTEER RELEASE AND WAIVER OF LIABILITY

Agreement, Waiver, and Release

In consideration for being permitted by the West Side Recreation and Park District to participate as a volunteer, I hereby waive, release, and discharge any and all claims for damages for personal injury, death, or property damage which I may have, or which may hereafter accrue to me, as a result of participation as a volunteer. This release is intended to discharge in advance the District (its officers, employees and agents) from any and all liability arising out of or connected in any way with my participation as a volunteer, even though that liability may arise out of negligence or carelessness on the part of the persons or entities mentioned above. It is understood that this activity involves an element of risk and danger of accidents and knowing those risks I hereby assume those risks. It is further agreed that this waiver, release and assumption of risk is to be binding on my heirs and assigns. I agree to indemnify and to hold the above person or entities free and harmless from any loss, liability, damage, cost, or expense which they may incur as the result of my death or any injury or property damage that I may sustain while participating in said activity.

Employee and Volunteer Background Screening

This questionnaire is to be completed by all potential employees regardless of position, and any volunteer being considered for a position having supervisory authority over minors.

Section 5164 of the Public Resources Code of the State of California prohibits West Side Recreation and Park District from hiring a person for employment at, or hiring a volunteer to perform services at, any of its parks, playgrounds or recreation centers used for recreational purposes in a position having supervisory or disciplinary authority over any minor, if the person has been convicted of certain crimes under the California Penal Code. Section 5164 also authorizes West Side Recreation and Park District to screen any such prospective employee or volunteer for his or her criminal background. In light of your interest in being hired by West Side Recreation and Park District for employment at, or being hired as a volunteer to perform services at, any of its parks, playgrounds or recreation centers used for recreational purposes, and in order to give effect to Section 5164 of the Public Resources Code of the State of California, please answer the following supplemental questions:
